NCI conserves biological diversity and natural resources in the American tropics through land purchase, creation of reserves and other programs for threatened ecosystems in the Latin America. While emphasizing the conservation of forests and ecosystems, NCI's programs also promote community sustainable development.

NCI has established and helps manage a regional conservation program in the Peruvian Amazon in collaboration with local governments and non-profit institutions. This program aims to conserve rainforests and biodiversity, create Regional Conservation Areas and provide sustainable development alternatives for neighboring communities.
